The 79,000-squarefoot worship center is known as a place for spiritual practice and serves as a community meeting place that accommodates numerous trainings, conferences, workshops, and much more.

# **POSITION OVERVIEW**

The Campus Security Officer is primarily responsible for providing security for St. Paul Baptist Church, and Dr. Ephraim Williams Family Life Center, staff, daycare students, buildings, and property. This will be accomplished through patrol of buildings and building perimeters. Also, includes patrolling parking lots to prevent unauthorized visitors or property damage and to provide general security. The Campus Security Officer will also work with the St. Paul Baptist Church contract secretary company.

#### **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- 1. Work with the Safety and Security Director, Executive Pastor, Daycare Staff on safety related matters.
- 2. Provide security for campus staff and Oak Park Pre-School staff, parents, and children.
- Monitor the Family Life Center entrance and exits for visitors, students, parents, and guests to address unauthorized persons.
- Respond quickly and appropriately to calls regarding unruly students and/or guests.
- 5. Secure parking lot when required, assist with directing traffic, and investigate any accidents as needed.
- 6. Maintain close relationship with contract security company.
- 7. Have a working knowledge of emergency evacuation procedures.
- 8. Maintain professionalism at all times.
- 9. Make your presence known by wearing proper security attire.
- 10. Be aware of surrounding

- 11. Deter, deescalate, and resolve any issues that may arise.
- 12. Provide debriefing with contract Security Company when a shift change occurs.
- 13. Ensure that security equipment and radios are properly working.
- 14. As needed conduct a sweep of the entire campus, inside and outside, looking for anything suspicious.
- 15. Report any suspicious activity to the Safety and Security Director.
- 16. Complete an incident report for all incidents.
- 17. Perform other duties assigned.

- 1. Working knowledge of latest security protocols and procedures.
- 2. Crowd management techniques.
- 3. Handling of hostile/hazardous persons or event.
- 4. Excellent written and verbal skills.

- 1. **Attention to Detail:** Ability to focus on tasks. Being alert to security events.
- 2. **Physical Fitness:** The ability to perform daily tasks with optimal performance, endurance, and strength. Having the ability to stand and walk around building.
- 3. **Critical Thinking:** Involves having the ability to examine a situation and objectively develop a conclusion. It is the ability to analyze a security threat.
- 4. Teamwork: The ability to collaborate and work with others.
- 5. **Customer Service:** The ability to properly interact with members, guest, and the general public. It may involve directing visitors to a building or explaining security procedures to event guest.
